MEASUREMENT AND EVALUATION HONOR AWARD

Criteria

- Previous recipients of the award may not be considered and deceased persons are not eligible for nomination.
- Criteria are as follows:
 - ✓ Must be a current member of SHAPE America and the Measurement and Evaluation SIG.
 - ✓ Must be recognized as having made outstanding contributions to the advancement of the Measurement and Evaluation SIG and its mission.
 - ✓ Must not be a current officer of SHAPE America or of the Measurement and Evaluation SIG.

Nomination

1. Supporting information for each nominee shall include the following: A letter substantiating how the nominee meets the award criteria, and the nominee's name, address and phone number.
2. The Chair shall obtain one- to three-page vitae from the nominee including the following: nominee's name, educational background, professional experience, and contributions to measurement and evaluation.

MEASUREMENT AND EVALUATION LIFETIME ACHIEVEMENT AWARD

Criteria

- Previous recipients of the award may not be considered and deceased persons are not eligible for nomination
- Criteria are as follows:
 - ✓ SHAPE America membership is not required.
 - ✓ Scholarly achievement in measurement and evaluation over a life span.
 - ✓ Significant impact in enhancing the theory and scholarly application of measurement and evaluation in Health and Physical Education.
 - ✓ Substantial (quantity and quality) scholarly record.

Nomination

1. Supporting information for each nominee shall include the following: a letter substantiating how the nominee meets the award criteria, and the nominee's name, address phone number, and email address.
2. The Chair shall obtain a one- to three-page vita from the nominee including the following: nominee's name, educational background, professional experience, and contributions to measurement and evaluation.

MEASUREMENT AND EVALUATION GRADUATE STUDENT SCHOLARSHIP

Purpose of Scholarship

The purpose of this scholarship is to assist graduate students focusing on psychomotor measurement and evaluation in paying their professional expenses.

Criteria

- Previous recipients of the scholarship may not be considered.
- Criteria are as follows:
 - ✓ Must be a current member of SHAPE America and the Measurement and Evaluation SIG.
 - ✓ Must be presently a masters or doctoral student pursuing studies focusing on psychomotor measurement and evaluation at a college or university in the United States.
 - ✓ Must have at least one more academic year of training after receiving the scholarship.
 - ✓ Priority will be given to candidates who have completed the first year of their degree program.

Nomination

1. Supporting information for each nominee shall include the following:
 - ✓ A letter of application from the nominee stating his/her professional goals, institution he/she is attending, and an outline of the degree program in psychomotor measurement and evaluation.
 - ✓ Two letters of recommendation specific to the scholarship and the nominee's potential for succeeding in both the degree program and as a professional in psychomotor measurement and evaluation, and academic transcripts from his/her undergraduate and graduate programs.
 - ✓ A one-to three page vitae from the nominee including the nominee's name, address, e-mail address, and phone number.

Number of Scholarships

A maximum of one scholarship can be given each year. The amount of the scholarship may not exceed \$1,000.

Notification

The recipient is to be informed of his/her selection by the Chair of the Measurement and Evaluation Advisory SIG. A certificate is to be prepared for the recipient whom is to be given at the subsequent annual breakfast/business meeting of the Measurement and Evaluation SIG held at the SHAPE America Convention.
